**ORDER**

**WHEREAS**, the institution **Leelavathi Shetty College of Education, Airport Road, Kavour Village, Anantha Arvade, 1<sup>st</sup> Floor, Mangalore, Dakshina Kannada District-575013, Karnataka** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/17265 dt. 21.01.2008 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

**AND WHEREAS**, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 22.01.2015, the provisional revised recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16.

**AND WHEREAS**, the institution submitted written representation requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. Accordingly, corrigendum order for reduction of strength from 2 units to 1 unit issued on 23.07.2015.

**AND WHEREAS**, the Show Cause Notice/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22<sup>nd</sup> Oct.2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. Accordingly, First Show Cause Notice was issued on 30.09.2019. The institution submitted its reply on 23.12.2019.

**AND WHEREAS**, the matter was placed before the SRC in its 390<sup>th</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August 2020. The Committee considered the matter and decided to issue Final show Cause notice to the institution to submit the representation to the conditions mentioned therein. Accordingly, a Final Show Cause Notice was issued to the institution on 08.09.2020. The institution has submitted its reply on 24.12.2020.

**AND WHEREAS**, the matter was considered by the SRC in its 393<sup>rd</sup> Meeting held on 5<sup>th</sup>-6<sup>th</sup> January 2021 as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -*

*On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Leelavathi Shetty College of Education, Airport Road, Kavour Village, Anantha Arvade, 1<sup>st</sup> Floor, Mangalore, Dakshina Kannada District-575013, Karnataka** for B.Ed programme for 1 basic unit of 50 students."*

**NOW THEREFORE**, the SRC decided to permit the institution i.e., **Leelavathi Shetty College of Education, Khata No.- 70/AP11, Airport Road, Kavoor Village, Anantha Arvade, 1<sup>st</sup> Floor, Mangalore, Dakshina Kannada District-575013, Karnataka** for **B.Ed. course** run by **Dr. M.V. Shetty Memorial Trust, A.B. Shetty Circle, Mangalore-575001** for continuation of recognition for **B.Ed. course of two years duration with an annual intake of 50 students (one basic unit)** subject to fulfilment of the following conditions:


- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
  9. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
  10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
    - a. Sanctioned programme(s) along with annual intake in the institution:
    - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
    - c. Name of faculty members who left of joined during the last, quarter:
    - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
    - e. Fee charged from students.
    - f. Available infrastructural facilities.
    - g. Facilities added during the last quarter.
    - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
    - i. The affidavit with enclosure submitted along with application.

- j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  12. The institution shall make available the list of students admitted on its official website.
  13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
